I agree to indemnify and save harmless the Yorba Linda Country Riders, owners of the Phil Paxton Equestrian Center, the City of Yorba Linda and singular, the directors, officers, members, employees and agents thereof from and against any and all loss, costs or expenses or any claim thereof, of whatever nature arising or to arise on account or by reason of the entry or entries hereby made.
